## **Regional Administrative Guidelines**

- I. Responsibilities of the Regional Officers and an explanation of how the region is governed.
- The officer's are divided into a Chair and Vice Chair. Alternating between Div 1 and Div 2 schools. Each handles eligibility for their respected division. The Vice chair acts as a liaison to the Chair in all matter pertaining to Div 2.and Vice versa. The regional Chair is the treasurer of the region and will handle all administrative matters and is the direct liaison to the National Office. Both officers are to attend the national convention and serve on committees when asked. The chair will conduct the annual meeting held by conference call the second Monday of September for one hour. The chair is to handle any issues that arise from the region and to actively recruit new members.
- II. Region Dues, \$ amount, purpose of dues, due date and all necessary information regarding the dues.
- Dues are paid by each member institution for the purpose of banner reimbursement and administration of the region. A stipend will be paid to the chair and vice chair for the purpose of their commitment to the region and to offset any costs related to the chairs travel to the national convention Dues are in the amount of \$227.00 and are payable by October 1 of each year.
- III. Member Attendance required at all region meetings/coach's meetings, purpose and institutional responsibility of voting.
- All members are required to be in attendance at the national convention for the purpose of having a regional meeting. They are also required to have all members have a representative participate in the conference call the first Monday of September. If members do not participate in the conference call, without just cause, said institutions could be fined in the amount of \$100.00. Fine money would be used for a ministry scholarship.
- IV. Eligibility Issues- Eligibility Chair – due dates, consequences.
- All eligibility forms must be submitted with proper signatures to the region chair for that division by the date of the first scrimmage for the particular sport. No exceptions. If not submitted in a timely fashion, said institution may be ineligible for post -season play. The national eligibility committee has the final say to all eligibility issues.
- V. Convening of Special Regional Sessions.
- If there is a matter, that needs to be addressed by the region, the regional chair can convene a special session. This session can be conducted by a conference call to be arranged by the regional chair.
- VI. Region Sport Chair's agenda for each coach's meeting.
1. Review playoff guidelines
  2. Review voting protocols for all region selections
  3. Set playoff dates and times along with declaration dates
  4. Submit playoff dates to the region chairs

## Sports Information Guidelines

- I. Statistics Dues, sport fees, deadlines, to whom.  
  
Statistical information due dates to be sent out by the national office to each institution's Sports Information Director. Fees & deadlines established by the national office
  
- II. Awards – Nomination Procedures, Voting Guidelines, Type of Award  
All are listed in the national handbook by each sport with guidelines and deadlines.
  
- III. All-American Selections – Procedures, Voting Guidelines, Presentation at National Championship  
Player of the year in each respective sport will be automatically be considered for all American selection. Each of those selections are sent to the national sport chair and the national office.  
VOTING GUIDELINES:
  1. Each coach will have a vote in the selection process of regional players of the year and all region selections. Votes will be tabulated by the regional sport chair and then submitted back to the coaches for a vote. Once they have been decided the region sport chair will tabulate and then select the all region team.
  
- IV. Ethics and Behavior – Players, Coaches and fans, Guidelines for presenting grievances, Consequences  
Any issue relating to ethics and behavior will be handled by the region chair on a case by case basis.. If a grievance is filed, it must first be submitted to the sport chair and then submitted to the region chair for consideration. If it is an issue, for national consideration, the region chair will the contact the national office for consideration. Each incident if it is a behavioral issue or a fan , player issue, should be handled in an appropriate manner by the institutions themselves.

### Individual Sport Guidelines

- I. **Playoff Plans – Dates for declaring participation/non-participation, Host site selection process, Requirements for representation at Regional/National Championships.**  
  
Date for declaration process will be no later than ten days before regional playoff. An exception to this declaration date if an institution is involved in a conference playoff. Host site selection will be by higher seed or by a rotational basis as voted on by the coaches and regional sport chair. The requirement for national participation will be to have one representative to the national tournament either by regional playoff or sport chair recommendation due to not having enough teams to hold regional tournament. The team that wins the regional must participate in the national championship, unless circumstances prohibit them from participation.

- II. Sport Policies for regional governance – Seeding, Structure of Regional Tournament, Tie breaker Procedures, Number of teams that participate in Regional Tournaments (sport-by-sport).  
Each sport will designate seeding structure. Most will be by higher to lower seed based on Burbridge or Longo system.

Volleyball	Four-five team tourney
Soccer	Four team Tourney
Basketball	Four to Five team Tourney with play in game of lower seeds (Rotational Basis)
Baseball	Four team tourney

Tournament will be conducted on a weekend when possible.

Since we use a rating system for playoff seeds, it is highly unlikely for a tie within the region. If there is a tie, then tie break will be either head to head during the year, if teams have not played then it would go to record against common opponent, if still tied then the higher seed would go to the team with the best overall record.

- III. Host site responsibilities – Visiting team’s responsibilities

Host team is responsible for all expenses incurred during the regional tournament. The visiting team is responsible for arranging transportation and lodging on their own accord.
